2	(a) In General.—Subchapter II of chapter 301 of

6	"(a) General Motor Vehicle Safety Stand-
7	ARDS.—
8	"(1) Rulemaking proceeding.—Not later
9	than 3 years after the date of enactment of this sec-
10	tion, the Secretary shall initiate a rulemaking pro-
11	ceeding to establish or modify, as applicable, safety
12	standards for motor vehicles to reduce the likelihood
13	of, and the number of deaths and injuries associated
14	with, collisions by considering certain features of
15	motor vehicles designed to protect covered road
16	users, including—
17	"(A) hood design;
18	"(B) bumper design;
19	"(C) windshield design;
20	"(D) vehicle height; and
21	"(E) vehicle weight.
22	"(2) Final rule.—
23	"(A) IN GENERAL.—Not later than 2 years
24	after the date of initiating such rulemaking pro-
25	ceeding, the Secretary shall issue a final rule
26	pursuant to paragraph (1).

1	"(B) Effective date.—The final rule
2	described in subparagraph (A) shall require full
3	compliance with each safety standard for motor
4	vehicles established or modified, as applicable,
5	pursuant to the final rule not later than 2 years
6	after the date on which the final rule is issued.
7	"(b) Motor Vehicle Minimum Visibility Safety
8	STANDARDS.—
9	"(1) Rulemaking proceeding.—Not later
10	than 4 years after the date of enactment of this sec-
11	tion, the Secretary shall initiate a rulemaking pro-
12	ceeding to establish minimum visibility standards for
13	motor vehicles to reduce the likelihood of collisions.
14	"(2) Final rule.—
15	"(A) IN GENERAL.—Not later than 2 years
16	after the date of initiating such rulemaking pro-
17	ceeding, the Secretary shall issue a final rule
18	pursuant to paragraph (1).
19	"(B) Effective date.—The final rule
20	described in subparagraph (A) shall require full
21	compliance with each minimum visibility stand-
22	ard for motor vehicles established pursuant to
23	the final rule not later than 2 years after the
24	date on which the final rule is issued.
25	"(c) Definitions.—In this section:

1	"(1) Collision.—The term 'collision' means a
2	crash between a motor vehicle and a covered road
3	user, including such a crash—
4	"(A) that occurs at a low speed; and
5	"(B) that occurs in a driveway, parking
6	lot, or private road.
7	"(2) COVERED ROAD USER.—The term 'covered
8	road user' means a pedestrian, bicyclist, or other
9	vulnerable road user.".

2	"(1) Notice.—Not later than 4 years after the
3	date of enactment of this subsection, the Secretary
4	shall publish a notice, for purposes of public review
5	and comment, to establish a means for providing to
6	consumers information relating to driver visibility of
7	pedestrians, bicyclists, and other vulnerable road
8	users, in accordance with subsection (a).
9	"(2) Inclusions.—The notice under paragraph
10	(1) shall include—
11	"(A) an appropriate methodology for—
12	"(i) determining which technologies
13	and design features shall be included in
14	the information;
15	"(ii) developing performance test cri-
16	teria for use by manufacturers in evalu-
17	ating technologies and design features;
18	"(iii) determining a distinct rating of
19	driver visibility; and
20	"(iv) updating overall vehicle ratings
21	to incorporate driver visibility ratings; and
22	"(B) such other information and analyses
23	as the Secretary determines to be necessary to
24	implement the rating of driver visibility.

1	"(3) Comparative ratings.—The Secretary
2	shall publish comparative ratings of the driver visi-
3	bility ratings described in paragraph (2)(A)(iv).
4	"(4) Report.—Not later than 5 years after the
5	date of enactment of this subsection, the Secretary
6	shall submit to the Committee on Commerce,
7	Science, and Transportation of the Senate and the
8	Committee on Energy and Commerce of the House
9	of Representatives a report that describes a plan for
10	implementing an information and rating system for
11	driver visibility, in accordance with subsection (a).".
